The college is running UG & PG Programs for Commerce, Economics, IT, Computer Science, etc. The curriculum at UG & PG level is designed and developed by Mumbai University. College has limited role in designing and developing syllabi as there are two faculty members on concerned Board of Studies. Arrangements to improve spoken English for students need to be introduced. College follows semester system (Credit Based) as per university norms. The gender equity needs to be strengthened in the college. The grievances of students are well taken care of. There is scope for more add-on courses to enrich the curriculum. Secular character and social harmony is well maintained in the college campus. NSS plays active role in the cross cutting issues like gender equity, environment and sustainability of human values by organizing various events. Formal feedback mechanism from various stakeholders needs to be improved.

Admissions made as per norms laid down by the University of Mumbai and the state govt. Nearly 1200 students are from reserved category. The college organizes awareness programs for slow learners. The college should conduct more programs for personality development, employability, skill development and all round development of students. College organizes field visits for students to gain learning experience. There are 17 teachers out of which 6 are Ph.D. Teachers need to be encouraged to pursue Ph.D. Recruitment of teachers under SFS be made as per UGC norms and be paid accordingly. College needs to appoint adequate and qualified teaching faculty as per intake and in accordance of UGC norms for smooth conduct of programs. College needs to encourage proper utilisation of ICT to strengthen teaching-learning process. College should approach the govt. to fill-up vacancies of teaching and non-teaching staff. Evaluation process framed by the affiliating university is followed by the college. Overall pass percentage of students is low and needs corrective measures to improve. Formal offline conduct of student satisfaction survey needs to be streamlined.

The institution is a recognized Research Centre of University of Mumbai. The college needs to sensitize faculty for conducting research and encourage them to apply for Minor/Major Research Projects as well as TRF/PDF. Library with ICT enabled facilities is helpful for research. No fund mobilisation for research is visible. Limited quality research publications and thus faculty need to be more research-oriented. Some teachers have published research articles in Journals and Books/Conference proceedings with ISBN numbers. Teachers be encouraged to attend national and international conferences by providing financial support. Non-Ph.D teachers be encouraged to enrol for PhD and pursue doctoral research. NSS is playing important role for Institutional Social Responsibility (ISR). NSS unit has adopted a village to help villagers in making them aware of health and hygiene, etc. The college needs to sign MoU's with other colleges/industries/NGOs to expand its extension activities.

The college building has well lit airy 18 classrooms out of which 7 with LCD projectors. Auditorium is used for academic and cultural activities. College needs English Language lab and a Commerce lab. The college has limited space available for expansion. More classrooms need to be constructed for smooth and proper academic delivery. College has partially computerized library with front-end library operations. Internet and Wi-Fi facility with suitably good bandwidth required. Computing facilities for IT/Computer related courses be augmented and upgraded in view of enrolled strength and prescribed norms. College has monitoring committee to take care of maintenance of buildings, equipments, etc. which takes care of renovation, repairing of building and equipments. More budget allocation for maintenance of infrastructure required.

More financial support for attending conferences, refresher courses be provided to the teaching staff for academic empowerment. Funds need to be provided to the faculty to attend conferences both at national and international level. Teaching faculty be motivated to indulge in quality research in the institution. Minor and major research proposals be submitted to the funding agencies for overall development of research culture. Regular performance appraisal for teaching and non teaching staff is in place. Both the internal and statutory audits are conducted. Student's feedback forms needs to be properly analyzed for quality improvement. Strategies need to be developed for mobilization of funds and optimal utilization of resources. The institute must start more self financed courses to raise funds for overall growth of the college.

The college Women Cell conducts programme for Gender sensitivity and other social activities related to women empowerment, women's rights & women self defence, etc. Separate common room for boys required. The college needs to have solid waste segregated into biodegradable and non-biodegradable waste. The waste generated from office and examinations is converted into notebooks, writing pads etc. and distributed to poor tribal girl students. E-waste management mechanism and rain water harvesting needs to be introduced. Green practices be strengthened. Use of rooftop solar panels be initiated for saving energy. Institute organises

festivals and anniversaries of great personalities. Learning Management System may be introduced.

All round development of students through value based education need to be focussed as per the emblem of the college which carries the message 'Satyam Param Dhimahi'. The college takes initiatives to engage with and contribute to the local community. Special measures are taken to clean neighbourhood area during Barka Eid every year to avoid risk of any epidemics. NSS volunteers participate in cleaning the area after Ganesh immersion procession at the end of Ganesh festival.
