### **Workshop duration**

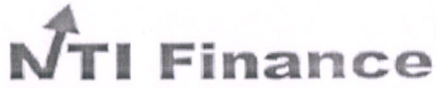
NTI will run basic workshop on Fundamental of Investment for 2 days for 6 hours in college premises.
