Memorandum of Understanding

This Memorandum of Understanding (the "MOU") is entered into on 22nd December 2022, by and between Family First Guidance Centre, with an address of Juma Masjid of Bombay, 46 Janjiker St, Near Crawford Market, Mumbai 400001, India and Akbar Peerbhoy College Of Commerce And Economics, with an address of MS Ali Road, near Do Taaki, Chhota Sonapur, Siddharth Nagar, Kamathipura, Mumbai, Maharashtra 400008, also individually referred to as "Party", and collectively "the Parties."

WHEREAS, the Parties desire to enter into an agreement to collaborate and coordinate various activities and the Parties desire to memorialize certain terms and conditions of their anticipated endeavor:

NOW, THEREFORE, in consideration of the mutual promises and covenants contained herein, the Parties agree as follows:

- Family First Guidance Centre will offer all their courses, workshops, and training at a nominal cost or without any
 cost if applicable to the students of Akbar Peerbhoy College of Commerce & Economics.
- Family First Guidance Centre will conduct career counseling sessions for the students of Akbar Peerbhoy College of Commerce & Economics.
- Family First Guidance Centre will conduct mental health and financial counseling sessions for the students of Akbar Peerbhoy College of Commerce & Economics.
- Family First Guidance Centre will offer internship opportunities to the students of Akbar Peerbhoy College of Commerce & Economics.
- Akbar Peerbhoy College of Commerce & Economics will provide the access to their halls, and conference rooms at nominal costs or with no cost if applicable for facilitating various programs and sessions for students or external
- Akbar Peerbhoy College of Commerce & Economics will assist in the promotion of various workshops amongst its students.
- This MOU should not establish or create any type of formal agreement or obligation. Instead, it is an agreement
 between the Parties to work together in such a manner to encourage an atmosphere of collaboration and alliance
 in the support of an effective and efficient partnership to establish and maintain objectives and commitments with regard to all matters.
- Objectives. The Parties agree as follows:
- The Parties shall work together in a cooperative and coordinated effort so as to bring about the achievement and fulfillment of the purpose of the MOU.
- It is not the intent of this MOU to restrict the Parties to this Agreement from their involvement or participation with any other public or private individuals, agencies, or organizations.

 The Parties shall mutually contribute and take part in any and all phases of the planning and development of the partnership to the fullest extent possible.

 This MOU is not intended to create any rights, benefits, and trust responsibilities by or between the Parties.

 The MOU shall in no way obligate either Party to supply funds to maintain and/or sustain the aforementioned activities.

- Term. This Agreement will begin upon the Effective Date, as stated above, and will continue until 31st December 2024
- Termination. This Agreement may be terminated at any time by either Party upon 30 days written notice to the other Party.
- Representations and Warranties. Both Parties represent that they are fully authorized to enter into this Agreement. The performance and obligations of either Party will not violate or infringe upon the rights of any third party or violate any other agreement between the Parties, individually, and any other person, organization, or business or any law or governmental regulation.
- Entire Agreement. The Parties acknowledge and agree that this Agreement represents the entire agreement between the Parties. In the event that the Parties desire to change, add, or otherwise modify any terms, they shall do so in writing to be signed by both parties.
