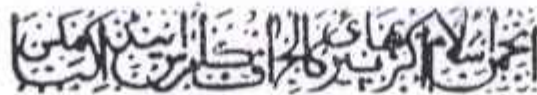

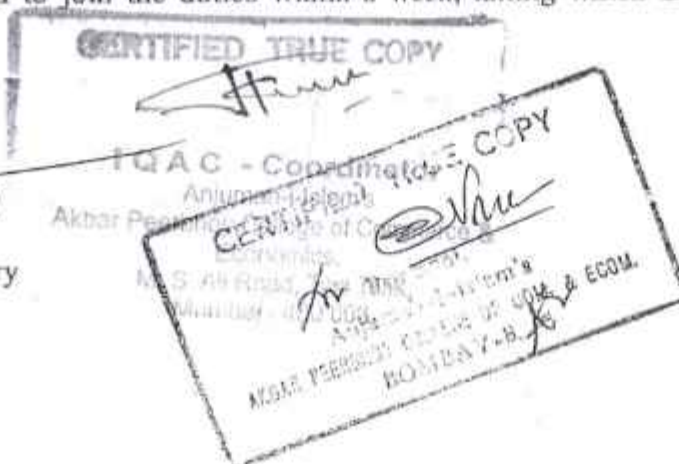
Sub : Appointment Order

With reference to your application dtd. 24.06.03 and the subsequent interview held on 28.06.03, I would like to inform you that you are appointed as a full-time lecturer in Accountancy on the following terms and conditions :

1. Emoluments : As per the U.G.C. Scale of Rs. 8,000-275-13500 and as per the Government Rules.
2. Probation : You will be on probation for a period of two years from the date of joining. However, if you produce a letter of completion of probation at Tolani College, the probation period may be waived off if the University Rules permit.
3. Your appointment is subjected to the approval of the University of Mumbai and the Joint Director of Higher Education and also subject to the availability of the requisite workload in the Department for you.
4. Your services will be governed by the provision of the Mumbai University Act as amended from time to time and the statutes, Ordinance, Regulations and Rules of the University for the time being in force and as amended from time to time and also by the provision of the Service Rules of the Governing Body of the College not in consistent with the Act, statutes, Ordinances, Regulations and Rules of the University.
5. You are requested to produce all your original certificates pertaining to your educational qualifications, birth certificate, etc.
6. You are also requested to submit your Experience Certificate, the Last Pay Certificate, Discharge Certificate, Service Book, etc. obtained from your last employer.
7. You are required to undergo a medical test and submit your medical fitness certificate to the undersigned within 3 months from the date of joining service in this college.
8. You are required to join the duties within a week, failing which this order will be treated as cancelled.
