# 1. EXECUTIVE SUMMARY

---

## 1.1 INTRODUCTION

Anjuman i Islam, Mumbai was founded in the year 1874 by a small group of devout & progressive people lead by none other than Dr. Badruddin Tyabji, third president of Indian National Congress and the First Acting Indian Chief Justice of Bombay High Court, with a 'desire to see the muslim community advance in education and social standing'. Anjuman i Islam's Akbar Peerbhoy College of Commerce and Economics was established in the year 1969. The location of the college was a conscious decision of the founders so that it would cater specifically to the community residing in the vicinity of the college. It is located in a minority dominated and deprived area, both economically and academically. Over a period of five decades the college is aptly nicknamed as a socially relevant and inclusive college.

The college strives to provide global standards of Commerce, Management, IT & Mass Media Courses. It also makes a concerted effort to develop a holistic personality of the pupils through personality enhancing activities.

Staying in tune with the Pluralistic and multicultural fabric of the nation, Anjuman-I-Islam's **APCCE** focuses on values of secularism and inclusiveness in word and spirit. There is equal focus on liberal, progressive and ethic based education. In this direction the core values are reinforced and revisited regularly. In short, we aim to produce responsible citizens who are committed to national development and at the same time abide with Global standards.

- Horizontal and vertical expansion of the college campus.
- Filling in the academic gap created by Covid and to reduce the dropout ratio specially among the minority communities.
- Upgrading and designing Institutional strategies to face challenges posed due to impending implementation of NEP from next academic year.
- Sustaining competition from a dozen colleges in the vicinity of 2 kms is another challenge.
- Sustaining & maintaining demand for the traditional flagship B Com course in the wake of newly introduced specialised UG courses in view of introduction of NEP .
- Lastly, keeping pace with changing demography and the urban landscape of the immediate locality.

## **1.3 CRITERIA WISE SUMMARY**

### **Curricular Aspects**

Our College is affiliated to the University of Mumbai and follows a curriculum prescribed by the University. Choice Based Credit System (CBCS) has been implemented by the University. Our Institute offers a varied range of course options catering to diverse sections of learners which includes 5 UG, 2 PG and 1 Ph.D. program and about 14 Certificate and Value-Added courses. The Institute follows a pre-drafted Academic calendar which is strictly structured as per University Guidelines to successfully accomplish the task of teaching and evaluation. The Institute has advanced ICT technologies to make teaching and learning more innovative and engaging. Experiential Learning opportunities are provided by the teaching staff, resource persons, reputed visiting academicians and industry persons. In this context field trips, industrial visits, guest lectures, and training workshops are conducted. About 1106 research projects and internships are undertaken every year. The

Program and Course Outcomes are structured in accordance with University Rules and Guidelines; and attempts are made to achieve the outcomes in accordance with the academic needs of the learners. The college offers 30 hours of Add-on and Certificate courses, including Skill Development courses. The courses that are offered to the learners are meant to enhance their learning experience, promote holistic development and empower them to succeed in their academic and professional pursuits. Our Institution has a mechanism in place to ensure Value- based holistic development for students and to sensitize them to relevant cross-cutting issues such as gender, environment and sustainability, human values, and professional ethics. Apart from the curriculum, the Institution made a concerted effort to transmit knowledge of each of the cross-cutting concerns through activities going beyond the regular curriculum. The Institution focuses on Continuous Internal Assessment (CIA) of students, which is accomplished through internal examinations, assignments, class activities, presentations, Group discussions, Bridge courses, and Remedial sessions for slow learners. Preparatory examinations/class tests are often held in college as a practice before final exams. Curriculum-related feedback is gathered from stakeholders and the feedback is analyzed. Stakeholders' suggestions are implemented through many enrichment programs at the Institute, and the effectiveness of these enrichment programs is evaluated.

### **Teaching-learning and Evaluation**

An important aspect in teaching - learning process of this Institution is the knack of its teachers to create fervor, ignite passion and generate inquisitiveness among students. Students are counseled at the entry level. Once the admission process is completed, next step entails facilitating students for participation in various curricular and co- curricular activities as per the academic calendar. Guest Lectures for students are conducted by inviting eminent personalities from various fields. IQAC of College monitors all curricular, co-curricular and extra-curricular activities and ensures provision of necessary support to teachers and students for an enhanced teaching and learning experience. The College has **2672** sanctioned seats across all courses in the academic year 2022-23. We offer 2 post graduate, 5 undergraduate and 1Ph.D Program.

The Institution follows the Reservation policy as laid down by the Government of Maharashtra in admission processes. Slow learners are identified through results as well as by teachers' observations and accordingly remedial coaching sessions are organized and additional class tests conducted. Student-centric activities like field-visits, workshops, student seminars, student's research conferences, film-screenings, role plays; exhibitions, socially-relevant awareness programs, etc are regularly organized by departments for offering students a wholesome learning experience. During Covid-19 Pandemic teaching-learning and evaluation process was conducted through an online mode. **The student-teacher ratio is 1:93.** Our college has a robust and transparent assessment mechanism and a well-established examination-related grievance redressal mechanism. The POs and COs are displayed on the College Website. For identifying curricular gaps and attainment of COs, student's performance in relevant subjects is thoroughly analyzed, feedback is obtained from resource persons and alumni and necessary changes are made for attaining of Objectives. Innovative Practices implemented includes YouTube channels that help self-employed learners to understand missed syllabus. Skill-oriented Certificate courses like Course on Hardware, Software & Networking, Digital Literacy and Marketing.College is Nodal Center for ISRO for promoting Space Research . On Job Training, Industrial and Field visits organized to provide practical exposure to students. During last five years, average pass percentage of students in Final Year examinations is 77 percent.

### **Research, Innovations and Extension**

Our College has a well-defined policy for promotion of research for faculty and students. Majority of our staff members are PhD holders or have registered for PhD. We have a Research Centre in the subject of Business Administration and Policy and there is one PhD Guide with 8 students registered under him. In all there are three Research Guides and sixteen research students enrolled under them. Teachers are encouraged to undertake quality research in emerging areas of relevance and to attend and participate on National/International Forums. Teachers have publications in Conference proceedings, Books, Peer-Reviewed and UGC Care journals. **Three Associate Professors of our Institution has participated and presented papers in foriegn countries like UK, Bangladesh etc.**

Faculty members are engaged in Minor Research Projects funded by ICSSR and University of Mumbai with Grants received to the tune of Rupees 5.09 lakhs.. Course work on Research Methodology was conducted by Research Cell. An ecosystem is created for transfer of knowledge through workshops on research methodology; entrepreneurship and IPR. Institute has several functional MOUs/Collaborations/ linkages for exchange of knowledge, experience, & ideas.

One of our teachers was granted Patent for a Device for Monitoring Employee Effectiveness in Work Place and the design was registered with the CG of Patents, Design and Trade Marks.

Extension activities are carried out by NSS, DLLE and Students' Council throughout the year. For the adopted village at Kotwalwadi, funds were raised to donate groceries, books, etc particularly during Covid. A Library was set up. A lecture on Significance of Mental Health was also organized for the school children of the adopted area during Covid. We received an Appreciation Letter from Neral Gram Panchayat and Certificate of Appreciation from Ministry of Aayush, GoI for the Institute's outstanding contribution during Covid.

Several Programs and Drives such as Physical and Mental Health-related, campaigns against Drug Abuse, Voter's Registration, Swachhata Abhiyan, tree plantations, blood donation, Re-cycling and beach cleaning, etc were organized by APCCE. Efforts are made to establish enriching collaborations with academic and non-academic institutions through MoUs to provide additional opportunities for extension, Innovation, internships, R & D, etc.

### **Infrastructure and Learning Resources**

Space is a major constraint in a city like Mumbai. Though limited in number and extent, APCCE boasts of having a mini campus with all necessary facilities.

The campus is equipped with extensive safety and surveillance measures, including 24/7 monitoring via 64 CCTV cameras and 2 DVRs. There are 18 classrooms supporting undergraduate (UG) and postgraduate (PG) courses, with 5 air-conditioned rooms, 8 equipped with LCD projectors, and all with WiFi and LAN facilities. Additionally, there are 3 air-conditioned computer labs with a total of 100 computers, projectors, scanners, printers, servers, and WiFi. The Principal's cabin is well-furnished and air-conditioned, featuring WiFi, telephones, a printer, and an LED TV for CCTV viewing. Staff rooms also offer air conditioning, computers, internet, WiFi, and individual lockers for teachers.

Facilities for examinations, the Internal Quality Assurance Cell (IQAC), mini-conferences, seminars, and gymkhana activities are available. The library, with a seating capacity of 120, is air-conditioned and equipped with reference materials, eBooks, journals, and internet browsing facilities. The college office is equipped with air conditioners, desktop computers, printers, and a photocopier. The seminar hall and mini-conference room offer WiFi, audio-video facilities, and seating arrangements for 150 people and are air-conditioned. The gymkhana provides indoor games facilities and outdoor sports equipment.

A spacious canteen caters to both students and staff, and the library has digital initiatives such as SOUL ILMS software, a webpage with new arrivals and online catalog access, and subscriptions to e-resources. Other facilities include the Vice Principal's cabin, research and NSS cells, a ladies' common room, store rooms, changing rooms, and a Permanent Stage. The college's IT infrastructure features advanced i7 Intel microprocessors, laptops, and internet with bandwidth ranging from 100 to 200 MBPS, enabling user-friendly online admissions. Adequate investment is made in infrastructure maintenance and augmentation.

The college has ambitious plans to repair, renovate the existing infrastructure and upgrade the ICT facilities and also add facilities for Divyang students. In order to prepare ourselves for NEP implementation the College aims to enrich the existing Library with books on IKS.

### **Student Support and Progression**

Akbar Peerbhoy College has always been a student-centric institution. Student Support Initiatives includes raising of funds for needy students through various NGOs and individuals including teachers in the form of donations and Zakat. Approximately 45 lakh Rupees were raised by the Institution to pay students fees. The Student's Book Bank Scheme is another distinctive initiative that the Institute takes pride in, wherein approximately 19,000 books were distributed among students in the last five years.

Every class has a teacher assigned for mentoring and counseling students. During their course of study, students can avail of a number of services for attaining personal growth in terms of career guidance, taxation and finance, language and communication, extra-curricular activities, co-curricular activities, cultural activities and sports. The Orientation by class-teachers provides necessary information for students on all aspects of campus life. All departments and different associations under the aegis of IQAC provide an opportunity to the students to interact with eminent academicians, reputed professionals, and leaders from the industry, eminent sportsmen and distinguished personalities from different walks of life. Students are given continuous access to the Library and its facilities. Information regarding financial support for the needy and other ancillary services is shared with students on a regular basis. The Placement Cell coordinates with in-house students and business organizations for campus recruitment.

Special emphasis is laid on protection of women's rights. Girls can address their grievance/s to Internal Complaints Committee, Grievances Redressal Cell or the Anti-Ragging Committee if situation demands.

Our sportspeople are true ambassadors and flag-bearers of our college who have brought glory to the Institution

by winning laurels at several Districts, State and National Level competitions. Students actively participate in extension activities through CWDC, NSS, DLLE and Students Council.

Career Guidance and Placement Committee Alumni in association with our alumni initiated “MEENARE-E-NOOR” in which well-placed alumni members are invited to address students on existing career options & required skills related to those professions. They whole-heartedly support the present students by sharing their network and references to land a job as well.

### **Governance, Leadership and Management**

The Vision, Mission and Motto of College proves to be a guiding light in smooth functioning of the Institution and provides direction for actions to enhance the value of education imparted by the college. Decentralization, Transparency and Participative nature of Management in decision-making and conduct of processes display institution's culture that values freedom of expression, an encouraging environment for all to participate and share innovative ideas. The Institution has well-defined organizational structure with hierarchical relationships of authorities and responsibilities. Recognizing the importance of technology in modern education, institution has embraced various e-governance services such as online admission, attendance and accounting. These technological tools play a pivotal role in streamlining processes, enhancing communication, and contributing to overall efficiency of institution's operations. This strategic incorporation of technology further exemplifies the institution's commitment to embracing contemporary trends and ensuring a forward-looking approach to education management. All recruitments are strictly guided by the stipulation and statutory requirements of Management, UGC & allied Statutory Bodies. Existence of a well-drafted Memorandum & Articles, and well defined organizational structure, with various governing bodies and councils is a reflection of our effective leadership in tune with Vision and Mission. Quarterly Board Meetings are conducted by Management for periodic evaluation/ATR and strategies to be adopted for future.

Management has decentralized the decision-making process so that it is democratic and takes interest of all stake holders. Our college has an exclusive CDC consisting of eminent members of Society and members representing teaching, non-teaching staff & Management to discuss and resolve pressing issues of college. Responsibilities are shared by different stakeholders to accomplish different tasks in achieving Institutional goals in decentralized manner. Institution has Performance Appraisal System in place and is executed as per Performance Based Appraisal System (PBAS) of UGC and related Academic Performance Indicators. Our Institution also undertakes Academic, Gender, Green and Energy Audits regularly and works upon improvising in areas that are found to be weak or requiring attention.

IQAC contributes significantly for institutionalization of quality assurance. It systematically maintains quality culture in departmental plans, teaching learning process, record maintenance of meetings, result analysis and students feedback.

### **Institutional Values and Best Practices**

Adhering strictly to its **Core Values**, *of catering to underprivileged class of society, bringing them to the mainstream; and contributing to inclusive growth*, the Management of our Institution believes in socio-economic and academic upliftment of the less-privileged and takes every possible effort in this direction.

This is clearly evident from Institution's policy of providing funds (through **Zakat**) and the **Book Bank**



**Scheme** to those who are unable to afford even basic course fees and books.

Secondly, considering the rapidity with which times are changing, regular efforts are considered necessary to instill inclusiveness, spiritualism; and ethical and moral values amongst students. With a thrust on promoting and strengthening traditional Indian knowledge and value system, our Institution strongly facilitates Seerat competitions at intra and inter-collegiate levels to encourage oratory and soft skills among students.

Efforts directed at Social Responsibility and Nation Building was evident when the Institution, Alumni and its students raised funds to donate grocery kits to the needy during lockdown.

Provide assistance to Mumbai Traffic Police almost every year during most festive processions. Adoption of Komalwadi village in Neral is a notable aspect of Institutional Social Responsibility. Books were donated through EK KITAB EK KALAM program and a library was set up at a school in adopted area. Our Institute engaged in activities that shoulder responsibility towards environmental consciousness. Labeling of trees existing on campus was undertaken to promote student's knowledge about botanical names of the trees. Our College was engaged in several tree plantations, awareness rallies and campaigns for socio-medical awareness. Energy efficiency is also considered of prime importance and the institution has shifted to LED lights across the campus.

Activities related to Gender equity and communal harmony are routinely taken up to foster an atmosphere of equality and brotherhood. Institution endeavours to provide an inclusive environment by sensitizing students on cross-cutting issues and empowering them to understand constitutional rights and responsibilities. Our Students have been taught Disaster Preparedness and Mitigation through relevant workshops and trainings. Transforming our students into responsible citizens with values, ethics, empathy, social responsibility, environmental consciousness, and inclusive behavior is the Core Belief.

The college undertakes methodical planning, effective execution and accurate documentation for each academic year.

The academic calendar is prepared before the commencement of the new academic year.

The college is affiliated to University of Mumbai, which publishes its term arrangement every year. This is the basic premise which the institute's Academic calendar is based on. Even the examination committee plan- both semester end examinations on the same time lines.

The Institute academic calendar is prepared by the IQAC, taking finer inputs from Head of the institute, Departmental heads, In charge of various associations and Examination Chairman . The academic calendar is displayed on the notice board and uploaded on the college website for perusal of all stakeholders.

It spells out a tentative schedule regarding admission, teaching learning, examination dates, Co Curricular and extra curricular activities to be organized.

The Continuous Internal Evaluation process viz. Class test/ assignment / presentations and practicals are discussed and their dates are decided and incorporated in the academic Calendar. The dates are notified to the students. The results of the CIE tests are analyzed and communicated to the students for enhancing their final performance.

Departmental meetings are conducted by the HOD's at regular intervals to allot the topic, prepare the lesson plan and monitor its timely completion.

Feedback on the teaching learning process is taken for improvement in current delivery and planning. Remedial lectures are planned to help students in their academic progress. Peer assessment is also done where feedback on the evaluation process is acquired from peers who visit college as external moderators.

**Response:**

Cross cutting issue receives its due importance and weightage in the entire teaching learning process. Since the college is affiliated to university Of Mumbai ,curriculum & syllabus has given by university of Mumbai is adopted by the institution . The cross cutting issues covered by the curriculum partly covers the topics on Professional ethics, Human values, Gender equality and Environmentally sustainable development are indicative, but not fully covered in any particular course. Areas which may be covered are inclusive growth, privacy and piracy issues, good governance, peace and security. The above issues are dealt across multiple courses like Business law, Economic, Auditing, Commerce, Foundation Course, Business intelligence . These issues are prominent in moulding students into good human being, emphatic towards social issues and a responsible citizen.

**Professional Ethics:** It is taught in the following courses: Advertising, Auditing, Business Law, Business ethics, Media law and ethics, crime reporting, business environment and digital Media. The coverage and depth differs from subject to subject. Field Visit to BSE, NSE and SEBI strengthens our teaching.

**Human values:** Human values are the soul of Indian culture. Topics such as foundation courses , Human rights, Consumer protection Act comprehensively teaches the intrinsic value of liberty, unity, integrity, humility, secularism and justice. Our college conducts Seerut Nabi elocution competition on the life of Prophet Muhammad Saw(PBUH) with the objective of enriching human values and character.NSS unit also strives to instill the importance of human values through extension activities.

**Gender Equality:** Gender diversity is globally recognized . Although genetic factors typically define a person's sex but gender refers to how they are identified on the inside. . Today gender studies not only covers women but also Cis gender, trans gender etc.

The syllabi in Foundation course, Business Law and Commerce specially deals with the provision of Law applicable to women and empowerment of women in the field of Business, education and Politics. Our college ICC and CWDC are very active in pursuing gender awreness & equality.

Response:

The college vision and mission is to admit students from the minorities and weaker section of the society and to drive them notch a higher as far as academic is concerned. Along with regular teaching and learning process, care is taken that they get hand-on and real-world experiences. It is ensured that they gain more skills, have a deeper understanding of the things they are studying and retain it for the longer period. All these provides them an experiential learning experiance. Various activities are carried by all the departments and to offer experiential learning opportunities such as: field trips to BSE, industrial visits, court visit for reinforcing classroom teaching. Along with experiential learning, collaborative or participative learning is also ensured in our college. Students are engaged in participative leaning process through Group discussion, hands-on projects, Interactive sessions through online quizzes or tests are carried out. Students do participate in the activities of DLLE, CWDC, NSS, cultural activities in good numbers. Also, they participate in departmental activities.

Problems solving methodologies are followed to allow learners to analyses and solve complex problems effectively. This way their critical thinking is developed. They are prepared to face the real-life situations related to the life as well as their profession. To facilitate critical thinking they are assigned project-based learning on subjects like Foundation Course, In the subject of Foundation course, questions on social issue and challenges are discussed with the students and also projects are assigned to facilitate in-depth understanding and problem solving techniques.

Learning based on case study is a regular pattern adopted by teachers. Students are asked to go through certain case-studies and shrare their insights after critically examining them. In the subject of Business Economics, market-based case studies are discussed in which such companies and brand names are considered that have been successful in cracking a crucial situation or business-related problems. Students are also made to appear for inter-state test on 'Indian Economy' conducted by SRAEF. Bridge courses are also conducted to improve subject understanding specially for the slow learners.

ICT based learning not only plays a crucial role but also enhances the efficiency of the learners and make them use it for more creative purposes. Today in Digital world, ICT-based education is playing a crucial role. The institutions has digital infrastructure to support digital teaching-learning process. In the pandemic and post-pandemic period, the use of ICT got boosted and almost every learner is accustomed to it. In enquiry-based leaning, advanced learners are motivated to explore or discover something fruitful related to their curriculum E.g Assembling electronic components for real world problems like IoT.

Some faculty members have YouTube channels which are accessed by regular students as well as self-employed learners to understand the missed syllabus. In the post-pandemic period, the class-wise group are being made and learners are kept connected through WhatsApp messages. All formal notices and study materials are shared with learners through the groups.

Being affiliated to University of Mumbai, the college has to follow standard policies set up by the University and we strictly adhere to the university guidelines with respect to the entire examination process. The college examinations (FY & SY) are conducted by adhering to the terms set up by the University for the Academic year. For the Final year examinations we follow the Time-Tables released by the University. Question papers are set as per the guidelines issued by the Board of Studies of each subject. The assessment of the answer books is as per guidelines set by the University. Moderation & Revaluation of answer books is conducted through experienced external evaluators from cluster colleges as per University norms. Results are processed and compiled after incorporating decisions taken by the Unfair Means Committee as per the rules, guidelines and ordinances as directed by University.

Students who missed FY & SY examinations on medical grounds or on account of representing college for NSS, DLLE, Sports and other co-curricular activities are given a chance to appear for Medical Examination which is conducted as-per University rules.

Students are promoted to higher classes as per University Rules. Students are given a chance to appear for supplementary examinations which are conducted twice a year.

Students having grievances about their results can apply for revaluation, verification and request photocopies of their answer books within stipulated time from declaration of results. Appropriate procedure is followed to get these answer books re-evaluated through competent evaluators from cluster colleges.

All notices regarding Time-tables, hall-tickets, Results and marksheets are communicated to students

through college notice-boards, ERP Student Diary App and Whatsapp groups.

The communication process is two way since the examination committee members are available for redressal of issues and guidance to students during college hours. In addition, the college maintains a special email id *apcce.exam@gmail.com* on which students can write to college and the committee responds back within 3 working days.

**COVID PERIOD:** During the pandemic since conduct of physical examinations was not possible due to Covid restriction guidelines, all examinations were conducted in online format as per university guidelines.. All examinations were conducted in MCQ (Multiple Choice Questions) format making use of Google forms and Google Presenter software. The software and its related modules & add-ons were effectively used by the Examination Committee as well as the IT cell for conduct of examinations. Even though the examinations were not video proctored, activities (log in - log outs) were monitored by the IT Cell and Examination Committee members to avoid use of Unfair Means and show cause notices were issued online to students found guilty of using Unfair Means. Students who faced technical glitches or problems during conduct of Regular examinations, were given a chance to appear for additional examinations. In addition to email id contact details of Examination Committee members and IT Cell members were made available to the students to help them reach out to college in case of any difficulty.

**Response:**

At Akbar Peerbhoy College we ensure attainment of outcome of various programs by taking into consideration diverse learners' profiles and knowledgebases. For this, learners are regularly assessed, and diverse initiatives are undertaken so that Programme Outcomes (POs) and Course Outcomes (COs) for all Programmes are attained.

**POs and COs outcomes are assessed through direct and indirect methods.**

**DIRECT METHOD:**

1. **Class room Observation:** Direct methods observations of student knowledge or skills against course outcomes in the classroom itself. While addressing the students, all teachers create awareness on POs and COs. By discussing the individual student performance in classroom, our teachers provide face to face feedback thus ensure that students have achieved desired level of competencies at module level.

2. **Hands-on Teaching:** Hands-on activities are designed to mirror real-life situations, showing students the practical applications of concepts of subjects they are been taught.
3. **Experiential learning:** Commerce, Accounts, Media, IT, Environmental Studies and Maths teachers use hands-on activities that involve experiential learning.
4. **Internal Assessment:** Internal Assessment constitutes 25% weightage of total marks in each subject. The students are given assignments as well as additionally, internal/class tests, quiz, viva etc. are conducted.
5. **End Semester University Examination:** Being affiliated to University of Mumbai, students of our college are required to take examinations as per the semester and annual pattern set by the university.
6. **Practical Assessment/ External Assessment:** It is evaluated by external experts appointed by the university to evaluate each student by conducting Practical examinations, and taking Viva-Voce and evaluating the practical files.
7. **Result Analysis:** At the end of each semester, result analysis of each course is carried-out indicating the percentage of students falling in different categories of CGPA. Whenever needed **remedial measures** are taken during formative assessment

#### INDIRECT METHOD:

1. Through language lab software students are immersed in an environment created by the software where the target language is spoken, and student can learn by practising in neutral environment it is based on gamified self-learning method. The student gradually moves from one level to another level. All first-year undergraduate students to devote 2 hours a week on language lab. Its parr of their timetable.
2. For the subject like economics, commerce, IT, Media & Management experts from relevant industries are invited to deliver **guest lecturs**.
3. Teachers Use **visual aids** like charts, diagrams, and graphs alongside hands-on activities to reinforce understanding.
4. **Field trips or visits** take places where program and course objectives is applied in the real world, It helps students see the applications of the concept they are learning.
5. Peer teaching promotes collaboration and reinforces understanding as students explain concepts to their peers.
6. **Mental health workshops:** Programs on mental health are regularly conducted in our institution.

The infrastructure and physical facilities provided by the institution for teaching- learning process is as follows:

1.Classrooms – The College has a total of 18 classrooms having different capacities of UG and PG courses. Out of these 05 classrooms are equipped with air conditioners. 08 class rooms have LCD projectors and 06 class rooms have audiofacility. All 18 class rooms are provided with wifi& LAN facility. College also has 3 air conditioned computer labs with a total of 100 computers with internet facility& Projectors .

2.Principal Cabin: - Principal’s Cabin is well-furnished with air-condition and Wi-Fi facility. With LED T.V. having CCTV viewing, 2 Telephones, Printer facility.

3.Staff Rooms: College has two air conditioned staff rooms, 3 Computers internet connections and Wi-Fi facility. Teachers are provided with individual lockers.

4.Examination Room has two computers, one printer, two Copy printers.

5.The IQAC Room has two desktops, a printer .

6.Laboratories – College has 3 Computer Labs with 100+ computers, 3 Projectors, scanner, 1 printer, server and Wi-Fifacility.

7. Library –Our Open Access spacious Library is fully air conditioned. It is equipped with reference books, eBooks and journals, necessary furniture. Library uses SOUL ILMS software. The Library reading Room has seating capacity of 120. There is separate cabin for Librarian & for teachers. Library has internet browsing centre with 6 computers.

8. College Office- Equipped with Air conditioners, 10 desktop computers & 6 Printers, and 1 photocopier machine.

9. Seminar Hall air is conditioned & Wi-Fi enabled with provision for LCD projector, & installed Audio & system, 4 air-conditioners and seating arrangement for 150 people.

10. Mini conference is Wi-Fi enabled with audio-video presentation facility.

11. Gymkhana is housed in a separate structure with indoor games facilities like Carom

boards, Table Tennis, Chess, punching bags & Boxing gloves. Separate cabin for Sports In-charge with computer. Gymkhana is equipped for playing outdoor games in the open ground, Volley Balls, Box Cricket etc. Cricket Bats, Balls and equipment & physical exercise equipments are also available.

12. A spacious canteen for students and staff is located in the college premises.

The college library has subscribed to 05, Journals, 10 Magazines and 18 Newspapers having all four Languages - Marathi, Hindi, English, Gujrati & Urdu. In addition to the above, access to 6200+ejournal titles and

**Finances & Funds of Akbar Peerbhoy College of Commerce & Economics are managed by Anjuma-I-Islam which is one of the oldest educational trust in India having completed more than 150 glorious nation building years. Since APCCE caters to economically under privileged class of the society, fund mobilisation is very crucial in order to achieve our primary objective i.e. to help the needy.**

**Sources of funds are as follows:**

- 1. Fees:** Fees charged as per the university and government norms from students of various granted and self financed courses.
- 2. Salary Grant:** The College receives salary grant from the State Government. For this, we prepare and send an annual budget of the estimated salary grant required to the state government. This grant includes salaries of the Full Time Permanent teachers and nonteaching staff as well as part-time teachers working on granted posts.

**3. Research Grants: Institute makes an attempt to apply for various Grants which are provided by UGC and other organisations.**

**4. Zakat & Other Donations: Anjuman -I- Islam our managing trust takes very keen interest in mobilising funds for paying fees of needy students under zakat system. NGOs, Individuals including teachers voluntarily come forward to adopt and sponsor students every year**

### **Purpose**

### **General Policy Principles**

2. The financial statements are independently audited by a qualified auditor in compliance with the Accounting Standards. The consolidated financial statement for the college is also independently audited by a qualified auditor in compliance with Accounting Standards.
3. After the year-end closing procedures, all audited and final financial statements and reports are scrutinized by CDC, and Anjum I islam's Board of Professional studies & Higher education
4. The Honorary treasurer of Anjuman I islam oversee and schedule all financial audits and liaise with the internal auditor as required with the help of CFO / Accountants.
5. External Audit involves audit of the institution by the Joint Director's Office, University Department Audit and the regular external auditor who does the audit as per the statutory requirements.
6. College uses accounting software to streamline financial processes, track payments, generate reports and ensure compliance with auditing standards. All the clarifications are provided when the questions are raised. The college maintains records of the audit reports.

College maintains financial transparency by regularly sharing financial reports and updates with stakeholders, including parents, faculty, staff and governing bodies. College continuously evaluate and adapt financial strategies and outcomes also, identify the areas of improvement, adapt to changing circumstances and stay updated on evolving financial management practices and regulations.

The Principal of the college stringently indulges in the whole procedure and supervises it sternly.

The Management Body of Anjuman-i-Islam firmly believes in gender equity and this is very well reflected in their core principles and routine functioning. The presence of a female representative in the Management Board is a shining example of its core policy.

The Management's Slogan BETI PADHAO BETI BASAO goes a step beyond in this aspect and has established an orphanage for girl child registered in the name of A D Bawala Trust and is in existence since the past five decades. It not just only provides them shelter, food and education but also gets them married when the time is right.

- As a part of Institutional Social Responsibility the Department of Information Technology provided Hands-on-Training on Internet of Things for 108 girl students on occasion of "International Women's Day and Girls in Science" to promote awareness about Science and Technology among girl students from Anjuman I Islam's School and Colleges
- The policy of the institution regarding gender equity and its promotion is implemented through the conduct of various programmes in each academic year with a focus on ensuring gender justice on campus, and creating support structures. One more notable thing is that girls employed as office staff are the ones who have completed their studies in the College itself.
- In the Institute we have a fair number of female staff in Degree and Self-Financing Section. The college has a separate ladies common room with a full time lady attendant on the 1st floor. A sanitary napkin vending machine has been installed on the first floor in collaboration with UJAAS NGO that works in the field of health and hygiene for women.

- The College has a fully functional Internal Complaints Committee as well as College Women Development Cell to cater to issues regarding safety and security of female students and staff. These committees conduct programs for counseling of girl students on several matters such as legal, gender-related, personality development, security and psychological issues. Experts from various fields and NGOs are invited as resource persons to enlighten the girl students. Several guest lectures on gender sensitization, Legal rights of Muslim women, Women’s safety, feminine health and hygiene, nutrition, pre-marital counseling, personality development, etc have been regularly conducted. Workshops on self defence and kickboxing have also been organized by the ICC and CWDC for the girl students. An online Guest lecture was organized on the topic ‘Building Resilience during Pandemic Period’.
- College also has set up the committee to conduct gender audit to promote more gender equality programs and measures along with existing one. The existence of the Anti-Ragging Committee as well as Discipline Committee also plays an important role to see to it that the girl students feel safe and secure at all times while being on campus.
- It is noteworthy that apart from CWDC, ICC and NSS, teachers play the mentoring role for the students round the year by counseling them to build harmonious and inclusive environment for all. All efforts by the Institute bore fruit when about 10 students were awarded as Best Volunteers by the NGO Akshara Centre for their consistent participation in gender-related workshops and other such programs.

**7.2.1**

**Response:**

**Best Practice – I**

1) **Title of the Practice:** Student Aid Fund/ Zakat Fund & Book Bank Scheme

2) **Goals (Objectives):** To Help the underprivileged students and ensure that their education doesn't get stalled for lack of resources. Keeping this objective in mind the institution ensures that books and funds are made available to as many needy students as possible.

3) **The Context:** A large number of students come from economically poor background, unable to even afford their college fees of Rs.6000. Some of them are first generation learners and some are compelled to take up jobs to support their families for survival. It is a plight that some of our students work in night shifts and then attend college in the morning. Since it is the mission of the Institution to help these students to get out from the quagmire of poverty, every possible effort is taken to make them graduates and help in the cause of Nation Building.

4) **The Practice:** The Student Support Initiatives at APCCE which specifically includes Book Bank scheme and the Students Aid Fund. The Book Bank Scheme is executed through a Book Bank Committee while the Student's Aid Fund facilitated through the Student's Aid Fund Committee ensures that maximum deserving students are benefited through this initiative. Immediately after the admission at the beginning of the term, notices are issued asking the students to apply for the Scheme. On receipt of the applications, the documents are scrutinized and personal interviews of the students are conducted; after which the books or funds are distributed to the deserving students, based on their respective requirements. With regards to the Student's Aid Fund, a notice is circulated in advance about the avenues and various schemes available to students in need of financial aid. Apart from the personal interviews, application forms, income proof certificates and copies of other relevant documents are received and processed, before distributing the aid to the needy students. Students are provided with maximum possible financial assistance from internal and external sources. The same was done during and after the pandemic too when the students' financial situation had further deteriorated.

5) **Evidence of Success:** Over a period of time the number of books as well as the amount of funds disbursed under the Student Support Initiative has increased which indicates that this scheme of the Institution has been very successful. More and more students have shown interest in availing the book bank facility and as such it has also contributed to the steady enhancement of the college results.

The table shows that Students Support Initiative has been successfully in place on a continuous basis over the years. 2020-21 and half of 2021-22 was the Covid period during which students faced several issues such as loss of either of the parents, financial losses, displacement, etc but the Management as well as the Staff managed to raise funds to the tune of 18.66 lakhs and provide it to the students who

were in dire need.

#### 6) **Problems Encountered:**

It is a huge challenge to identify students who are genuinely in need of funds to pay for their admission or to buy books. At times it may so happen that a slightly better off (financially) student may get the facility instead of the one who is more desperately in need. So

Secondly arrangement of increasing amount of funds for student's aid and procuring more and more books for distribution under this scheme also becomes a tough predicament for the Institution.

#### **Best Practice – II**

##### 1. **Title of the Practice: Seerat-un-Nabi** (Ethical & Moral Values)

1. **Goal (Objectives):** The objective is two-pronged and aims to instill ethical and moral values and at the same time prepare them to polish their oratory/public speaking skills

3) **The Context:** Considering the rapidity with which times are changing, regular efforts are considered necessary to instill inclusiveness, spiritualism; and ethical and moral values amongst the students. With a thrust on promoting and strengthening traditional Indian knowledge and value system, our Institution deems it fit and necessary to involve as many students as possible in this endeavour. The importance of public speaking for our students is taken very seriously and therefore all these aspects were combined and the outcome was that the Seerat Committee was established to facilitate the competitions at both intra as well as inter-collegiate levels. Seerat Committee was formed in our College about three decades ago.

4) **The Practice:** Intra and inter-collegiate Seerat-un-Nabi competitions are held in the college consistently every year. Those with a strong hold over spiritual knowledge are invited to guide the participants and judge the events. Participants are allowed to deliver their speech in either English or Urdu. They are judged for their content & on their oratory skills. Students from our own college & colleges located in the vicinity participate in the annual event in large numbers. The numbers are so large that one or sometimes two elimination rounds have to be conducted to select the best speakers only for the final rounds

5) **Evidence of Success:** This practice of organizing the Seerat-un-Nabi competitions is unique to our college as none of the other colleges in South Mumbai conduct such competitions. The participation rate is also phenomenal and not a single year has passed by without having a Seerat competition. Our College takes pride in highlighting that we have an increasing number of participants from several colleges and the participating students come from different religious backgrounds. This is the biggest success for our college as we come across as an Institution that promotes Social Inclusiveness through our approach towards academics as well as co-curricular activities.

### **Portray the performance of the Institution in one area distinctive to its priority and thrust within**

Adhering strictly to its **Core Values**, of catering to the underprivileged class of society, bringing them to the mainstream; and contributing to inclusive growth the Management Body of our Institution strongly believes in the socio-economic and academic upliftment of the less-privileged and takes every possible effort in this direction. This is clearly evident from the Institution's policy of providing funds (through the collection of **Zakat**) and the **Book Bank Scheme** (provision of sets of textbooks) to those who are unable to afford even the basic course fees.

Our college is located in the close vicinity of Kamathipura, the infamous red-light area of Mumbai and other areas such as Kumbharwada, Madanpura, Dongri, Bhendi Bazar, Chor Bazar, etc. A majority of our students come from these areas and are first generation learners. Many of them take up odd jobs and work as night shift workers to support their families. Installment facilities are offered to students to pay their college fees. Despite the fact that we have learners coming from such economically depressed backgrounds, we are able to churn out graduates and post-graduates who have transformed not only into good citizens but also into successful artists, professionals and entrepreneurs.

Distinctiveness of the Institution will be evident through the initiatives taken up for the students as well as by the students under the guidance of the teachers.

**Adherence to the Vision and Mission** is evident in most student activities that involve carefully crafted ideology by the Institution. Emphasis lies on creating citizens who can contribute to the growth of the Nation through transformative socio-economic processes. To instill inclusiveness, spiritualism, ethical and moral values amongst the students with a thrust on promoting and strengthening traditional **Indian Knowledge and Value system**, it was decided to combine public speaking with spiritualism to come up with a novel and unique initiative called **Seerat** Competitions that are held at both intra as well as inter-collegiate levels.

A shining example of **Social Responsibility and Nation Building** was evident when the Institution, Alumni and its students came ahead during the lockdown to serve the Covid-affected communities. Funds were raised and grocery kits were distributed to those badly hit due to the lockdown.

Our students assist the Mumbai Traffic Police in **Crowd and Traffic Management** during Ganpati Processions, Eid e Milad celebrations and Mahaparinirvan Din.

**Adoption of Komalwadi village** in Neral is another notable aspect of our Institutional Social Responsibility. Initiatives taken up at Komalwadi are:

- Set up a **Library**. Conducted session on Mental Health for the students in collaboration with NGO MPower. Through the **EK KITAB EK KALAM** program, distribution of about 300 books, stationery items and even clothes. Distribution of **Grocery kits**. Through **Shram-Daan** our students helped clean the school campus and prevented mosquito infestation in the area.

1. Distributed clothes and woollens to the tribals living in Vasai and donated **3000 sanitary napkins**

to school girls.

**Environmental Consciousness** of the Institution is visible in the following:

Tree plantations on Campus, at Komalwadi and also at Wadi Bandar. Butterfly Garden developed at Wadi Bandar. Watershed management done at Maharashtra Nature Park.

- General awareness to celebrate Bakr-Id in the most environment-friendly manner.
- Approximately 36 kgs of plastic waste was gathered and donated to Global Green Resonance Foundation.
- SAY NO TO PLASTIC BAGS Project - more than 2000 paper bags made out of old newspapers distributed at the pharmacies.
- Similarly, old discarded clothes collected and recycled into cloth bags and distributed in the nearby market.
- Participation of students in the webinar organized by UNEP & KAASH Foundation's Centre on The way forward to Sustainable Environment.

Under the **Swachh Bharat Abhiyaan**, activities carried out on and off the Campus are:

- Cleanliness of Anjuman School Bus Stop area
- Beach cleaning of Girgaum (org by F3 News), Juhu and Mahim beach
- Students made a video on importance of maintaining hygiene and uploaded it on various social media platforms.

In the field of Personality Development as well as **Mental and Physical health** of the students, Institutional efforts are prominently visible. Mental health-related and Digital Literacy programs took centre-stage particularly Post Covid 19. Our students participated in Blood donation, Drug Addiction Awareness, Say No to Drugs Project (in collaboration with NGO Red Ribbon Club), and awareness generation Rallies about Organ Donation, HIV, Thalassemia, etc. They also participated in the Nasha Mukti Abhiyaan organized by the Public Welfare Dept, GoI, at the University level.

In an effort to train students in **Disaster Management and Disaster Preparedness** several programs were conducted. They were trained by the Civil Defense Wing of Mantralaya in fire-fighting, offering first aid and other life saving techniques.

Our College firmly believes in preaching and practicing Inclusiveness. Our students have participated in several **Peace Rallies** to propagate the message of peace and fraternity. They also attended UMANG 2020 the **Spiritual Talk at ISKON**; Hiroshima Peace Rally organized by Gandhi Sarvodaya Mandal and also in the **Bhajan Sandhya** organized by Mumbai University.

- Our students have been **Spreading Smiles and Joy** during their visits to shelter homes, jails, etc. Visits were paid to Ashadan Shelter home, Juvenile home at Dongri; and the Jail at Byculla and held a dialogue with them. They also carried some sweets and goodies for the in-mates.
- **'Khayal'** an initiative to study social behavior of different groups of people
- Our students participate in the Inter-Collegiate Festival **UDAAN** which generally focuses social awareness and on giving opportunities to college students in the relevant fields.
- Under the Financial Literacy Program for the Youth, Dept of Economics of our College, in collaboration with BSE Broker's Forum, offered a **free Online Crash Course** on Share Market

Fundamentals for college students.

Transforming our students into responsible citizens with values, ethics, empathy, social responsibility, environmental consciousness, and inclusive behavior will go a long way in carving a **Success Story** for the students and in turn for APCCE.
